

AHFC ENERGY PROGRAMS

HOME ENERGY REBATE PROGRAM

Alaskan homeowners may participate in the Home Energy Rebate Program. There are no income requirements. Only owner-occupied, year-round residences are eligible.

Homeowners pay upfront and then receive a rebate for making the eligible improvements. Before (“As-Is”) and after (“Post-Improvement”) energy ratings are required.

Individuals may not participate in both the Weatherization Program and the Home Energy Rebate Program.

The program is subject to funding availability.

WEATHERIZATION PROGRAM

This program is for individuals who meet certain income guidelines for eligibility. It provides free weatherization assistance for homes, rentals and multifamily dwellings. The program has been in existence almost 30 years and has contributed to substantial energy savings throughout the state.

LOANS FOR HOMES

Energy-Efficiency Interest-Rate Reduction Program

Homebuyers purchasing existing or newly constructed homes may receive an interest-rate reduction for energy efficiency. The maximum interest-rate reduction is .75 percent on the first \$200,000 of an AHFC loan. The program may be combined with the Home Energy Rebate or New Home Rebate.

Second Mortgage Program for Energy Conservation

Homeowners may finance up to \$30,000 of energy-efficient improvements, choosing from a list of upgrades included on their home energy rating. This program is often combined with a Home Energy Rebate.

Association Loan Program Homeowners’ Associations may borrow money for common-area improvements, including energy upgrades.

Small Building Material Loan Borrowers with residential property located in “small communities” may receive a home-improvement loan of up to \$20,000. Improvements may include energy efficiency and renewable energy.
