Chugach Manor Designated Housing Plan

This plan designates Chugach Manor as an “elderly” facility. The plan specifies that:

- 104 units are reserved for families classified as “Elder”;
- 12 units are designated as UFAS wheelchair accessible units;
- 4 units are designed as UFAS sight/sound accessible units.

1. HUD Approval

The designated housing plan for Chugach Manor is approved in accordance with the requirements of Section 7 of the U.S. Housing Act of 1937 and PIH Notice 2010-28.

2. Elder Units

These units are reserved for families (or individuals) where the head, spouse, or co-head is at least 62 years of age. Staff will work the waiting list in order and offer these units to all elderly families first. Once those families are exhausted, staff may offer to disabled families that are not elderly.

3. UFAS Wheelchair Units

These units are reserved for a person with a disability that requires the features of the unit. Staff will select families for these units in the following order.

1. Elderly individuals from the Chugach Manor transfer list that require the features.
2. Other individuals from the Chugach Manor transfer list that require the features.
3. Elderly individuals from the Anchorage transfer list that require the features.
4. Other individuals from the Anchorage transfer list that require the features.
5. Elderly individuals from the Chugach Manor waiting list that require the features.
6. Other individuals from the Chugach Manor waiting list that require the features.

4. UFAS Sight/Sound Units

These units are reserved for a person with a disability that requires the features of the unit. Staff will select families for these units in the following order.

1. Elderly individuals from the Chugach Manor transfer list that require the features.
2. Other individuals from the Chugach Manor transfer list that require the features.
3. Elderly individuals from the Anchorage transfer list that require the features.
4. Other individuals from the Anchorage transfer list that require the features.
5. Elderly individuals from the Chugach Manor waiting list that require the features.
6. Other individuals from the Chugach Manor waiting list that require the features.
