Notes:

- The FNMA 3170 1-4 Family Rider is only required on 2-4 unit properties. When using the FNMA 3170 1-4 Family Rider, items E and F must be deleted and initialed
- On Rural Non-Owner Occupied loans, use FNMA 3170. Item E must be deleted and initialed.
- On all VA loans, the Note must have the assumption clause. The D/T must have the assumption clause or the VA Assumption Rider must be used.
- For a loan with a Community Land Trust (CLT), use AHFC Form PUR-201.
